

NB Private Equity Partners Announces Monthly Net Asset Value Update for August 2013

NB Private Equity Partners Limited (“NBPE” or “the Company”), a closed-end private equity investment company, today announced an updated Net Asset Value (“NAV”).

As of 31 August 2013, the unaudited estimated NAV per share was \$11.98, which was unchanged compared to the unaudited, restated NAV per share of \$11.98 at 31 July 2013. Including the cumulative dividends paid in 2013 of \$0.41 per Share, NBPE’s total return unaudited NAV per Share was \$12.39 which was unchanged compared to the unaudited, restated total return NAV per Share of \$12.39 at 31 July 2013.

The value of NBPE’s private equity portfolio as presented in the August 2013 monthly report was based on the following information:

- 41% of the private equity fair value was valued as of 31 August 2013
 - 24% in private direct/co-investments based on 31 August 2013 valuation information
 - 10% in credit-related fund investments
 - 7% in public securities
- 1% of the private equity fair value in a private direct/co-investment was valued as of 31 July 2013
- 58% of the private equity fair value was valued as of 30 June 2013
 - 36% in fund investments based on Q2 2013 valuation information
 - 22% in private direct/co-investments based on Q2 2013 valuation information

During August, NBPE’s portfolio value increased due to \$1.9 million of unrealized gains attributable to the receipt of new valuation information, \$1.4 million of accrued cash and PIK interest from its direct yielding investment portfolio, \$0.3 million of unrealized gains on credit-related fund investments, and \$0.1 million of positive foreign exchange adjustments. These gains were offset by \$1.6 million of unrealized losses on public securities. There were no shares repurchased during the month of August.

During the month of August, NBPE’s aggregate trading volume on Euronext Amsterdam, the London Stock Exchange, and over-the-counter trading platforms was 365,014 shares, which represents an average daily trading volume of approximately 16,592 shares. The trading volume in August included approximately 107,304 shares traded over-the-counter and not reported on Euronext Amsterdam or the London Stock Exchange.

NBPE expects to continue to provide regular NAV updates within seven business days of each month’s end.

Please refer to the valuation methodology section of the monthly report for a description of our valuation policy. While some valuation data is as of 30 June 2013 and 31 July 2013, our analysis and historical experience lead us to believe that this approximates fair value at 31 August 2013.
