

NB Private Equity Partners Announces Monthly Net Asset Value Update for April 2013

NB Private Equity Partners Limited (“NBPE” or “the Company”), a closed-end private equity investment company, today announced an updated Net Asset Value (“NAV”).

As of 30 April 2013, the unaudited estimated NAV per share was \$11.81, which represents 1.1% increase compared to the unaudited estimated NAV per share of \$11.68 at 31 March 2013.

The value of NBPE’s private equity portfolio as presented in the April 2013 monthly report was based on the following information:

- 21% of the private equity fair value was valued as of 30 April 2013
 - 11% in credit-related fund investments
 - 10% in public securities
- 58% of the private equity fair value was valued as of 31 March 2013
 - 39% in private direct/co-investments based on Q1 2013 valuation information
 - 19% in fund investments based on Q1 2013 valuation information
- 21% of the private equity fair value was valued as of 31 December 2012
 - 21% in fund investments based on Q4 2012 valuation information

During April, NBPE’s portfolio value increased due to \$3.9 million of unrealized gains attributable to the receipt of Q1 2013 valuation information, \$1.1 million of unrealized gains on credit-related fund investments, \$0.8 million of unrealized gains on public securities, and \$0.7 million of positive foreign exchange adjustments. There were no shares repurchased during the month of April.

During the month of April, NBPE’s aggregate trading volume on Euronext Amsterdam, the London Stock Exchange, and over-the-counter trading platforms was 2,511,230 shares, which represents an average daily trading volume of approximately 119,582 shares. The trading volume in April included approximately 2,052,920 shares traded over-the-counter and not reported on Euronext Amsterdam or the London Stock Exchange.

NBPE expects to continue to provide regular NAV updates within seven business days of each month’s end.

Please refer to the valuation methodology section of the monthly report for a description of our valuation policy. While some valuation data is as of 31 December 2012 and 31 March 2013, our analysis and historical experience lead us to believe that this approximates fair value at 30 April 2013.

NBPE expects to issue its interim management statement for the three month period ended 31 March 2013 in May. The interim management statement will include unaudited financial information prepared in accordance with accounting principles generally accepted in the United States. NBPE is required to consider, and will consider, all known material information in preparing such interim financial report, including information that may become known subsequent to the issuance of this monthly report. Accordingly, amounts included in the interim management statement may differ from this monthly report.
