

NB Private Equity Partners Announces 30 September 2017 Quarterly Report

1 December 2017

NB Private Equity Partners Limited (“NBPE” or the “Company”), a closed-end private equity investment company, today releases its Quarterly Report for the period ended 30 September 2017. Key highlights and commentary are below and the complete Quarterly Report can be found on the Company’s website at www.nbprivateequitypartners.com.

Key Highlights

- 30 September 2017 Net Asset Value (“NAV”) per Share of \$16.76 (£12.50) increased \$0.85 (-£0.39) from \$15.91 (£12.89) NAV per Share at 31 December 2016
 - NAV per Share total return of 8.7%
 - NAV per Share increase was driven by realised investment gains and portfolio yield income, offset by dividends paid and expenses
- NBPE’s NAV increase of \$41.2 million during the first nine months of 2017 included:
 - \$84.1 million of realised gains, or \$1.72 per Share, net of tax expense
 - \$5.5 million of unrealised losses, or (\$0.11) per Share, net of tax expense
 - \$11.6 million of yield income and dividends, or \$0.24 per Share
 - \$4.2 million of interest and other financing costs, or (\$0.09) per Share
 - \$18.6 million of management fees, operating expenses, and other expenses, or (\$0.37) per Share
 - \$1.8 million of losses on foreign exchange related to ZDPs and investments, or (\$0.04) per Share
 - \$24.4 million of dividends paid, or (\$0.50) per Share
- NAV development during 2017 to date has been as follows:

Portfolio Commentary

- **Strong cash flow:** \$210.4 million of distributions received during the nine months of 2017
- **Year to Date Realisations:** \$96.3 million of proceeds received as a result of full sales of Evans, Deltek, Gabriel Brothers, Patheon, Ortholite, Capsugel and Oticas Carol, which in aggregate generated a 4.4x multiple (inclusive of prior distributions)
- **New investments:** 13 new equity investments and 10 new income investments completed in the first nine months of 2017 totalling \$163.5 million; total contributions of \$182.1 million, including follow-on investments
- **Direct investment focus:** 85% of fair value invested in direct equity and income investments at 30 September 2017

¹ Assumes reinvestment of dividends on the ex-dividend date and reflects cumulative returns over time period shown.

Portfolio Valuation

The value of NBPE's private equity portfolio as at 30 September 2017 was based on the following information²:

- 89% of the private equity fair value was valued as of 30 September 2017
 - 79% in private direct investments and fund investments
 - 8% in public securities
 - 2% in credit-related fund investments
- 11% of the private equity fair value was valued as of 30 June 2017

Outlook

NBPE continues to benefit from the full resources of the Manager's integrated private equity platform for superior deal flow, due diligence and execution capabilities. The Manager believes that while many segments of the market remain competitive, there are a number of near-term opportunities that may be attractive investments for the portfolio and that the current investment pipeline remains strong.
